



MEMORANDUM OF UNDERSTANDING

This MOU is entered at BCIP Kalkaji, New Delhi on November, 2022

(Agreement for the use of clinical facilities of IBS Hospital for practical training of Bachelor of Physiotherapy and Master of Physiotherapy students of Banarsidas Chandiwala Institute of Physiotherapy, managed under the aegis of Shri Banarsidas Chandiwala Sewa Smarak Trust Society, affiliated to Guru Gobind Singh Indraprastha University, recognized by Delhi Council of Physiotherapy and Occupational Therapy)

This Agreement is entered into on November 16, 2022 between Banarsidas Chandiwala Institute of Physiotherapy, Chandiwala Estate, Maa Anandmai Marg, Kalkaji, New Delhi, 110019 and IBS Hospital,73 Ring Road, Lajpat Nagar-3 New Delhi, 110024

Banarsidas Chandiwala Institute of Physiotherapy has approached, IBS Hospital, New Delhi to allow use of clinical, hospital beds facilities for providing practical training (Department of Orthopaedics, Neurology, Medicine, Surgery, ICUs and Wards etc) for their students (BPT/MPT).
