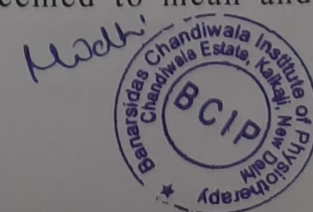
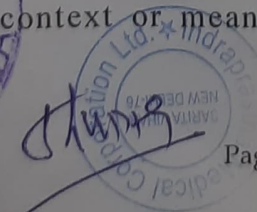
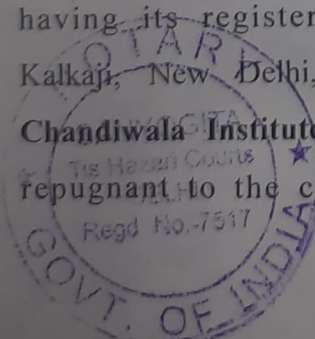
THIS Memorandum of Understanding (hereinafter "MoU") is entered at Delhi and is effective as on 13<sup>th</sup> day of September, 2023 between:

#### PARTIES

M/s **Indraprastha Medical Corporation Ltd**, a company incorporated in India under the provisions of the Companies Act, 1956, (who is engaged in providing healthcare services under the name and style of Indraprastha Apollo Hospital), having its registered office at Sarita Vihar, Mathura Road, Delhi-110076 (hereinafter referred to as "**Indraprastha Apollo Hospital**") which expression shall, unless repugnant to the context or meaning thereof, be deemed to mean and include its successors in interest and assignees acting through its authorized representative **MR. HEM GUPTA** who is a duly authorized person to enter upon the present MoU, of the **FIRST PART**;

AND

**Banarsidas Chandiwala Institute Of Physiotherapy**, is an education institute having its registered office at, Chandiwala Estate, Maa Anandmai Marg, Kalkaji, New Delhi, 110019 (hereinafter referred to as ("**Banarsidas Chandiwala Institute Of Physiotherapy**") which expression shall unless repugnant to the context or meaning thereof, be deemed to mean and



include its successors in interests and assignees acting through its authorized representative **MS NIDHI KALRA** who is a duly authorized person to enter upon the present MoU(authorization of the authorized signatory to be obtained) of the **SECOND PART**;

That Indraprastha Apollo Hospital and Banarsidas Chandiwala Institute Of Physiotherapy shall wherever the context requires be collectively be referred to collectively as "Parties" and individually as "Party" hereto.

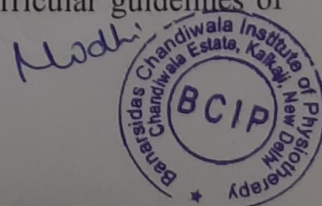
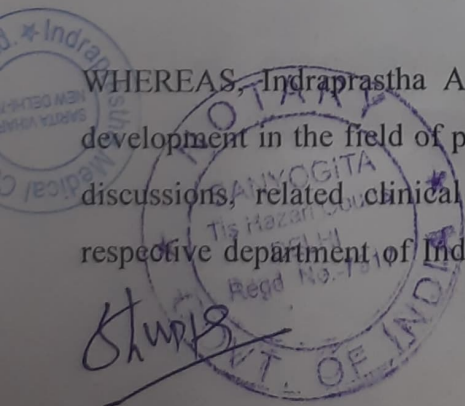
### RECITAL

WHEREAS, Indraprastha Apollo Hospital is engaged in providing healthcare services.

WHEREAS, **Banarsidas Chandiwala Institute Of Physiotherapy**, is an educational institute conducting UG and PG (MPT Ortho and Sports) program in the field of physiotherapy. That it is managed under the aegis of Shri Banarsidas Chandiwala Sewa Smarak Trust Society, affiliated to Guru Gobind Singh Indraprastha University and recognized by Delhi Council for Physiotherapy & Occupational Therapy.

WHEREAS, Indraprastha Apollo Hospital agrees to allow the students of **Banarsidas Chandiwala Institute Of Physiotherapy** to use clinical facilities for gaining practical training in OPD, IPD and other different departments like Orthopedics, Neurology, CTVS, Medicine, Pediatrics & Surgery, Burns, Plastic Surgery, Transplant Unit, ICUs, etc. for BPT & MPT during their internship/clinical training period with Indraprastha Apollo Hospital.

WHEREAS, Indraprastha Apollo Hospital agrees to allow hands-on training, skill development in the field of physio-rehab, community-based rehabilitation, theoretical discussions, related clinical presentation/symposia, dissertation work etc held at respective department of Indraprastha Apollo Hospital as per curricular guidelines of



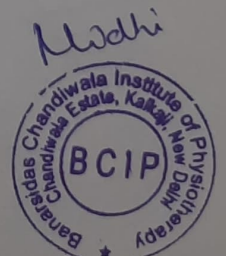
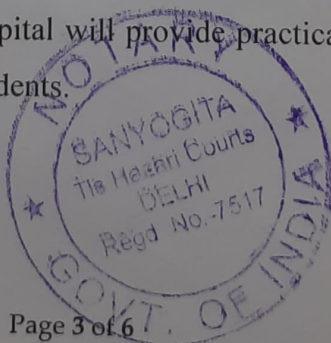
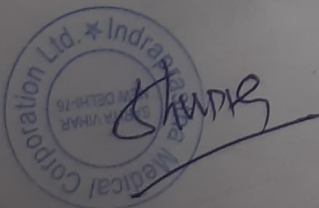


GGs Indraprastha University & the Delhi Council for Physiotherapy & Occupational Therapy applicable for the program.

WHEREAS, Indraprastha Apollo Hospital agrees to collaborate with **Banarsidas Chandiwala Institute Of Physiotherapy** and allows their students to intern with them to gain practical and clinical experience in the field of physiotherapy.

### Terms And Conditions

- 1.1 That Indraprastha Apollo Hospital will allow only a limited number of interns from Banarsidas Chandiwala Institute Of Physiotherapy each year and the number of interns is to mutually decided by both parties.
- 1.2 That Indraprastha Apollo Hospital is not obliged to offer employment to any intern from Banarsidas Chandiwala Institute Of Physiotherapy.
- 1.3 That Indraprastha Apollo Hospital shall provide no monetary compensation to the students of Banarsidas Chandiwala Institute Of Physiotherapy during the course of internship with Indraprastha Apollo Hospital.
- 1.4 That during the internship period the students of Banarsidas Chandiwala Institute Of Physiotherapy shall conduct themselves in a proper and professional manner and shall not exploit any resources of Indraprastha Apollo Hospital.
- 1.5 That Indraprastha Apollo Hospital will provide practical exposure of practices under physiotherapy to the students.



- 1.6 That Indraprastha Apollo Hospital will strengthen various aspects of advanced Clinical Learning for betterment of budding physiotherapy professionals to meet better learning outcomes.
- 1.7 That both parties will ensure that there is healthy interaction and communication between the interns and the faculty/staff members.

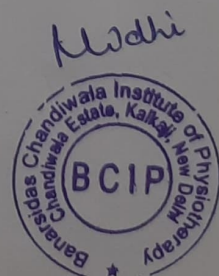
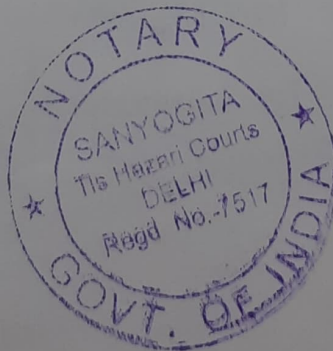
## 2. DURATION OF THE MoU

- 2.1 The present MoU shall be valid for a period of 3 years from the date of commencement.
- 2.2 Either parties can terminate the present MoU by giving a three months advance notice to the other Party.
- 2.3 That three months before the expiration of the MoU based on mutual consent between the parties, the term of this MOU may be extended for a further period of one year.

## 3. GOVERNING LAW AND JURISDICTION:



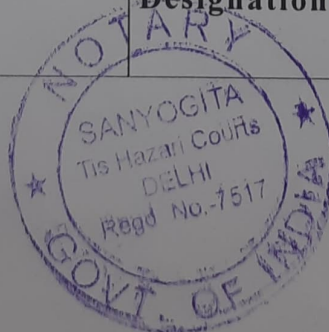
## 4. ENTIRE MoU:




